1. All prices are subject to change without notice at any time prior to the signing of the bid sheet and receipt of deposit from purchaser.
2. Any cancellation by Purchaser of this purchase will entitle Moby1 to a cancellation fee of twenty-five percent (25%) of the contract price. Moby1 shall not be required to refund the balance of any deposit made by Purchaser until such time as Moby1 has been able to sell the unit contracted for by Purchaser to an alternative purchaser.
3. Moby1 makes no guarantee or warranty as to the date of completion or delivery of the trailer contracted for in this agreement. However, in the event the project extends beyond 18 months purchaser may request and receive a full refund.
4. Purchaser shall take possession of the unit contracted for within fifteen (15) days of being notified of its completion by Moby1. Beyond 15 days a minimum storage fee will be charged of not less than \$100 per week.
5. The balance of the purchase price shall be due at time of completion, and before delivery or shipment. Personal checks are not acceptable for final payment.
6. Purchaser shall be responsible for any and all fees charged to Moby1 as a result of payment by Purchaser with Paypal or a major credit card. Currently, those fees are estimated to be between 2.7% and 3.7%. Moby1 prefers payment through wire transfer. Alternative methods of payment can be arranged directly with Moby1.
7. This Agreement shall be interpreted and enforced in accordance with the laws of the State of Utah. Jurisdiction for the consideration or resolution of any dispute between the parties to this Agreement shall be established exclusively in Utah County, State of Utah.
8. In the event of a default in any of the terms of this Agreement, the prevailing party shall be entitled to all costs of enforcement of this Agreement, including reasonable attorneys' fees.
9. This agreement contains the entire understanding between the parties with respect to the subject matter of this agreement. There are no other agreements, understandings, representations or conditions, express or implied, oral or written, with regard to this Agreement. This Agreement may not be modified or amended other than by an Agreement in writing.
